Mandatory prevention and safety measures for sex work

To fight the COVID-19 epidemic, you have an obligation to observe the following protective measures.
Controls could be executed.



In case of symptoms*, do not work, stay at home and get tested. **Do not have sex with a symptomatic client*** and vice versa, do not have sex with a symptomatic sexworker*.

- Persons who have been in a country or zone with a high risk of infection and who enter Switzerland must be quarantined and not work during this period.
- Your clients must be informed of the obligation to collect their personal informations, which must be destroyed 14 days later and **can be forwarded in the meantime to the cantonal doctor's office if a positive case or outbreak situation is identified. The CoGa application** is recommended, or an Excel table kept up to date with the surnames, first names, telephone number of the clients, name of the provider, time. You must also give them your professional number so that you can be notified in case of infection of a client.
- As for any other service to the population, the **practice of sexwork is prohibited between 7:00 p.m. and 6:00 a.m., as well as on Sundays.**
- Wear a mask within the entire erotic center (common areas, before and after services, movement).
- **Wash your hands** upon arrival, as well as before and after each service, with water and soap or hydro alcoholic gel. 
- Encourage clients and workers to take a shower before and after each service.
- Use condoms for all sexual practices. 
- No direct contact between clients' and workers' mouths.
- **Ventilate** the room, **change sheets and towels** between clients.  
- **Clean** accessories between clients.
- **Regularly clean surfaces** (doorknobs, doorbells, tables, etc.) and remove unnecessary objects that clients may touch (magazines, etc.).

- Have a **garbage** can available, if possible closed, to throw away masks, tissues, condoms and empty it once a day.



- Do not accept trios or more.

- Everyone is encouraged to use the Swisscovid application (allows you to be notified of a time spent with a person who subsequently tests positive using the Swisscovid application).

- In case of symptoms*, **contact a doctor by phone**, or Aspasia or take an appointment in a COVID screening center **



***Symptoms :**

- The main symptoms are :
 - Sore throat, dry cough, shortness of breath, chest pain
 - Fever
 - Sudden loss of smell and/or taste
- Other possible symptoms :
 - Headaches
 - General weakness, feeling of discomfort
 - Muscle aches and pains
 - Cold
 - Nausea, vomiting, diarrhea, stomach pain
 - Skin rashes
